

Troubleshooting Career Technical Education (CTE) Reports

Overview

CTE reports are generated using EMIS data reported by Local Education Agencies (LEAs) who report CTE data. Potential and actual CTE FTE values for students enrolled in CTE programs appear on the reports. Student, course, and staff errors for CTE programs are included on separate CTE reports. This presentation will provide data verification and error resolution guidance.



Formatting the CTE FTE Detail Report

The next series of slides will demonstrate these Excel basics

- Wrap text header row
- Freeze top row
- Expand all columns
- View formatted report with default sort
- Apply filters

Wrap Text Header Row

First select the header row by clicking on the number "1"

Then from the Home tab select "Wrap Text"

Quick Check

CTE reports contain a large amount of data and should be reviewed often. Knowing how to prepare the reports using Excel can make the data review process much easier. Saving your work between reviews can be helpful in troubleshooting issues over time.

Understanding the CTE FTE Detail Report

CTE FTE Detail Report

Contains rows of CTE data by student and by each CTE course they are enrolled

- Students with changes to their Student Standing (FS) and/or Student Attributes Date Effective (FD) Records can have multiple rows of data on the CTE FTE Detail Report

The first column contains the IRN of the LEA receiving the report

CTE FTE Detail Report Data, cont'd

Result Code "SC0000" and Result Code Description "CTE Base FTE" are not error codes

The Severity Code is set based on a comparison between the original FTE and the adjusted FTE

- CTE FTEs with an "F" Fatal Severity Code are reduced to zero
- CTE FTEs with a "C" Critical Severity Code are reduced but not to zero
- CTE FTEs with an "I" Information Severity Code are not reduced

CTE FTEs

Career Tech is funded through student CTE FTEs

- Students associated with multiple LEAs can appear on more than one CTE FTE Detail Report
 - For example, students who attend community schools will also appear on the resident district's CTE FTE Detail Report since the funding passes through the resident district
- CTE FTEs are calculated for each row on the report
 - Students can have multiple CTE FTEs calculated for the same course due to changes to their Student Standing (FS) or Student Attribute Effective Date (FD) Record

FTE Fund Patterns

 - Indicate how the funds will flow for that specific CTE FTE row

 - When blank, the funding goes to the Initially Funded IRN

Inclusion Codes

- Inclusion Codes indicate where the CTE FTE will be counted

CTE Errors

Requesting CTE Overrides

CTE Overrides

- When CTE EMIS data is correct and CTE errors are generated, sometimes it is appropriate to request an override
- Once an override is approved, a CTE Approved Override Report will be generated in the Staff and Course (L) Collection Level 2 Reports
- The approved override will restore the CTE FTE for students effected by the error and the error will no longer appear in a CTE error report

CTE Approved Overrides

Contains Result Codes indicating where student CTE FTE is transferred to or from the entity receiving the report

- SC0150 – Open enrolled student funded elsewhere, funding transferred in
- SC0160 – Open enrolled student funding initially received, funding transferred out
- SC0170 – Non open enrolled student funded elsewhere, funding transferred in
- SC0180 – Non open enrolled student initially funded, funding transferred out
- SC0190 – Student educated at community school or STEM, funding transferred in to the community school or STEM
- SC0200 – Student educated at a community school or STEM, funding transferred out from the resident district

CTEA-009 Example

Review the report to verify that all students who have funds transferred appear with correct and consistent CTE FTE values and watch for fluctuations

Note the Warning (W) in the last row on the report due to the increase of more than 20% between the thirty day average and the latest run

Summary

- The CTE reports contain data to verify and issues to correct
- The troubleshooting process requires interaction between the CTE FTE Detail Report and the error reports
- Use the CTE FTE Summary Reports to verify data and to compare data from previous versions of the reports
- Confirm that corrections have been made in the source system and that new EMIS data has been submitted in order for CTE reports to be updated
